Industry Overview

The process plant machinery sector in India caters to a wide range of process industries like oil and gas, petroleum refining, fertilizers, chemicals, petrochemicals, oleochemicals, pharmaceuticals, metal processing, cement, paper, sugar, food processing and water treatment. The industry is equipped with modern machinery, in addition to competent engineers and labour, and produces sophisticated equipment and systems like: high pressure reactors, pressure vessels, columns, towers, heat exchangers, multi tubular reactors, evaporators, crystallizers, dryers, road/rail tankers, storage equipment, mineral beneficiation equipment, rotary kilns and separators, etc. for the domestic as well as the global markets.



The key growth drivers for the industry are expected to be:

- Make in India initiative by the Government of India which is expected to drive investments in the chemical and allied sectors like chemicals, petrochemicals, fertilizers, textiles, leather chemicals, etc.
- Innovation in machinery to get a major boost with the Government's focus on 'Zero effect, Zero defect' and intelligent water management through 'Clean Ganga' initiative.
- The Government of India, as per the 12th Five Year Plan (2012-17), has allocated a budget of approximately US\$ 165 million for the development of the process plant equipment market in India.
- Total investments in manufacturing pegged at \$ 1.35 Tn, with infrastructure investments pegged at \$ 1 Tn as per 12th five-year plan.

Skill India mission, an initiative by Government of India to raise skill penetration of the country will help provide the much-needed skilled labour for the process plant machinery in India.
